**GENERAL**

**PUBLICATION IN TERMS OF REGULATION 11.04.4(2) REGARDING THE PARTICULARS ON AN EXEMPTION FROM THE REQUIREMENTS OF REGULATION 64.01.2**

The Commissioner for the Civil Aviation has granted an exemption as per CAR Part 11.04.04, authorizing sixty (6) Air Namibia Cabin Crew to operate on a ZS registered aircraft.

Air Namibia has entered into a lease agreement with SAFAIR ending 31<sup>st</sup> December 2006, whereby SAFAIR will carry out Air Namibia's aircraft maintenance. To accommodate any scheduling disruptions that may occur, the parties signed a lease agreement that makes provision for Air Namibia to utilize SAFAIR's B737-200 when required.

The sixty cabin crew are authorized to exercise the privileges of a Cabin Crew Member on any of the B737-200 aircrafts motioned below:
