SECOND AMENDMENT OF THE MORTGAGING OF AIRCRAFT
REGULATIONS 1997

The Minister of Transport has under section 14(1) read with section 14(5) of the Convention on the International Recognition of Rights in Aircraft Act, 1993 (Act No 59 of 1993), made the Regulations in the Schedule hereto.

SCHEDULE

1. Definition

In these Regulations, unless the context otherwise indicates, the "Regulations" means the Mortgaging of Aircraft Regulations, 1997, published by Government Notice No R.1739 of 24 December 1997, as amended by Government Notice R.436 of 28 March 2003.

Amendment of Regulation 8 of the Regulations

2. Regulation 8 of the Regulations is herewith amended by the substitution for the said regulation of the following regulation:
